2023 DOGTOBERFEST TERMS AND CONDITIONS

1. **PAYMENT TERMS:** Deposit and payments on this contract are non-refundable. This contract is non-cancellable, and payments noted on this contract must be made on time. Regarding late or non-payment, DogtoberFEST may exercise the right to resell the space and terminate this contract. Booth reservations must be made in advance of the DogtoberFEST. A 50% deposit at the time of the booth selection is required to guarantee specific space. any transaction within two weeks of set-up date must be a bank transfer, cash or certified check. The show is non-refundable if the show should be postponed or canceled due to fires, Acts of God, or other causes beyond the DogtoberFEST Pet Expo's control, then it shall not be in any manner financially liable to Exhibitor
2. **LATE CHARGE:** the total cost of booth must be paid by 30 days prior to first day of the expo. DogtoberFEST reserves the right to charge a 10% late fee. Also, to hold a company's inventory in the event of non-payment due PetCon pet expo for rent, electric, decorator items, or other monies due.
3. **SET-UP:** exhibitors must be set-up and ready for business one hour prior to the show. All exhibitors arriving late for their designated set-up time will be subject to a new set-up time approved by **DogtoberFEST** . **NOTE:** exhibitors will not be allowed to set up any displays or merchandise if all rent and monies due per this contract have not been paid in full.
4. **SECURITY:** The Waterfront will provide security throughout the entire event from initial set-up to final tear down. DogtoberFEST or The Waterfront will not be liable to the exhibitor, his employees, agents, or guests for any loss or injury from theft, damage, fire, electricity, water, storm, riot, smoke, or any other cause.
5. **DISPLAYS:** All displays must remain completely set up and manned for all hours of the show, up to and including 4pm on event day. Early teardown is not safe and against the Waterfront venue safety rules and subjects PetConnections to a fine. Early teardown will subject the exhibitor to a \$300 fine and non-renewal of space for future DogtoberFEST
6. **APPROVED PRODUCTS/EXCLUSIVITY:** Products and services to be sold must be listed and subject to final approval by DogtoberFEST . DogtoberFEST reserves the right to stop any sales of products not approved on the list with this contract. Failure to cease in sales of unapproved products or services will subject exhibitor to immediate removal from the show. Food sales and pet food/treats must have USDA license. No product exclusivity will be honored unless specified on Line 12 of this contract and approved by initials of the DogtoberFEST representative.
7. **NOISE:** DogtoberFEST will determine acceptable sound level. Devices that produce sound must be operated so as not to disturb other exhibitors.
8. **SUBLETTING:** Participation in the DogtoberFEST is subject to final approval by PetConnections. Subletting or sharing of space in any form is prohibited unless explicitly written in line 12 and signed by an authorized DogtoberFEST representative.
9. **PETS/ANIMAL POLICY:** To have a pet at your booth, you must complete pet registration form for each pet with proof of vaccines and good behavior, to exhibit pets. All animals must be under the handler's control at all times to ensure the safety for everyone. All animals must be treated humanely during the event. No wild or exotic animals allowed on premises. On-site Adoptions or **SALES OF ANIMALS STRICTLY PROHIBITED!**
10. **INSURANCE:** It is recommended that Exhibitors have comprehensive general liability insurance for bodily injury and property damage from a solvent company licensed to do business in the State of PA is recommended. All animals must be under Exhibitor control and DogtoberFEST shall not be held liable for injuries or property damages arising from incidents. It is agreed that any litigation regarding this contract shall be litigated in the appropriate Court in the State of PA. The responsibilities of DogtoberFEST are limited to those listed within this contract and shall not be held liable for any promises made by any of its representatives in the event of non-payment; this contract becomes the sole responsibility of the signer.
11. **ADVERTISING:** Exhibitor gives PetConnections Magazine & DogtoberFEST the right to use their name in PetConnections Magazine, all DogtoberFEST advertising, and the official show program. DogtoberFEST agrees to sufficiently advertise the show using PetConnections Magazine, TV, radio, and additional local print media. DogtoberFEST and/or PetConnections magazine forbids the use of their name or logo without prior written approval and may be cause for removal from the PetConnections and voiding of this contract.
